1. This tournament is open to all female Twin Cities USBC Members.
2. Non USBC members may purchase a Twin Cities USBC Association Membership on site.
3. Youth Bowlers will be allowed to bowl in this event with all monies going into the USBC Smart Account in their name if they qualify for the prize fund.
4. Entry into the 2024 USBC Queens will be awarded to the highest placing entrant that meets all criteria to enter the 2024 USBC Queens.
5. Entry Fee $=\mathbf{\$ 9 0 . 0 0}$. All prize fees are returned $\mathbf{1 0 0 \%}$. Optional Sr Queens Entry will be $\mathbf{\$ 2 5 . 0 0}$ with toward the Sr. Queens Entry free.
6. Entries will close after the first 96 paid entries are received.
7. A paid entry becomes the property of the Twin Cities USBC (no refund of entry fees.)
8. PRACTICE WILL START AT 8:50 AM Check-in begins at 7:30AM
9. 8 games Qualifying begins at 9:00 AM.

Top 8 will bowl match play based on 47 or fewer entries, 48 - 71 entries top $1672-95$ entries top 24,96 entries and above, top 32.
10. 1 game roll off will determine the winner of any ties for last place for match play. A 9th and 10th frame will be bowled if a tie still exists.
11. The Match Play finals are a 1 game double elimination format with the winners decided by a one game total pinfall. A 9th and 10th frame roll off will determine the winner of any ties.
12. The USBC rule prohibiting use of any abrasive on the surface of the bowling ball during competition WILL BE ENFORCED with immediate disqualification and forfeiture of entry fee. Dry towels only are allowed during competition.
13. NO ENTRIES ARE RESERVED WITHOUT ENTRY FEES.
14. Winner will have 30 days to inform the Bowling Office as to her intentions of going to the National Queens Tournament, if the Champion is not able to go, the 2nd place bowler will be asked to go. After that prize money will be added into next year's prize fund.
