TOURNAMENT RULES

PLEASE READ CAREFULLY

USBC Certified #04725

1. EVENT DIVISIONS

TEAM EVENT:

Scratch Division - Four person team with any average.
Handicap Div. I - Four person team average of 628 and over
Handicap Div. II - Four person team average of 627 and under.

DOUBLES EVENT:

Scratch Division – Two person team with any average.
Handicap Div. I - Two person team average with 314 and over
Handicap Div. II - Two person team average with 313 and under.

SINGLES EVENT:

Scratch Division – Single person with any average.
Handicap Div. I - Single person average of 157 and over
Handicap Div. II - Single person average of 156 and under.

ALL EVENTS:

Scratch Division - Nine game total pins, any average.
Handicap Div. I - Nine game total pins with 157 and over.
Handicap Div. II - Nine game total pins with 156 and under.

2. AVERAGE ENTRY REQUIREMENTS

Bowlers must use their highest USBC certified average for the 2025-2026 season based on a minimum of 21 games, including spring/summer and/or Sport/Challenge leagues. Sport/Challenge league averages will be adjusted per rule book adjustment rate.

If a bowler does not have a 2025-2026 certified average, the bowler shall use their highest current seasons USBC average at the time of participation of 12 games or more in one league (must bring current standing sheet).

All other bowlers will be required to bowl scratch (220).

3. CURRENT AVERAGE 10 PIN RULE

USBC Rule 319a/2 (ten pin rule) does not apply. Rule 319a/1, 3 and 4 does apply. Rule 319c. Average Adjustments (rerating) does apply. Rule 319d (Reporting Prior Prize Winnings) does apply. (Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain, or others. Average corrections can be made up to the end of the bowler's first game of a series. Or, if an extension of time has been granted in writing by the tournament management before the end of the first game of a series, the correction can be made within 48 hours after the end of the series.

4. ENTRY FEES

\$30.00 PER PERSON per EVENT Breakdown as follows:

Prize Fee (returned 100%).....\$15.00
Lineage.....\$12.00
Expense Fee.....\$ 3.00

Payback will be 100% of the prize fee collected on a 1 in 4 ratio

All Events: Handicap \$5.00 (Optional) \$1.00 from each Handicap All Event will be donated to Bowl for the Cure.
Payback will be returned 100% on ratio of 1 in 8.

Team Scratch \$40.00 (Optional)

Doubles Scratch \$20.00 (pair) (Optional)

Singles Scratch \$10.00 each (Optional)

All Events Scratch \$10.00 (Optional)

Payback will be 90% of the amount collected on a 1 in 6 ratio.

5. TERMINATION CLAUSE

Twin Cities USBC will return entry fees only in the event the tournament is prematurely terminated due to causes beyond their control. The Twin Cities USBC Association shall be liable only to the extent of returning entry fees. Prizes will be pro-rated to the actual number of participants.

6. HANDICAP AND SCRATCH

Team Event- Scratch shall be: 880

Doubles Event - Scratch shall be: 440

Singles & All Events - Scratch shall be: 220

Handicap shall be 95%, no limit.

7. ELIGIBILITY

All bowlers must be Adult Female members of Twin Cities USBC association. Bowlers from other associations must purchase local membership \$10.00 (plus \$3.00 State fees if applicable). Associate membership will be available for purchase (\$28.00)

8. PARTICIPATION

A bowler may bowl the team event three times. A team must change at least two (2) bowlers. Bowlers first score in the Team event will be used in All Events. Bowlers are **NOT** entered in the ALL Events unless the entry fee **ACCOMPANIES** the entry blank. Bowlers may bowl only once in the Singles and Doubles events. All six games will be bowled on the same pair of lanes.

WALK IN ENTRIES WILL NOT BE ALLOWED

9. RESERVATIONS

To reserve a date and time, call (763) 971-0800. **Entries are now open and will close November 20, 2026. All reserved entries must be received in the office or postmarked by October 30th.** Entries without advance reservation will be accepted if openings are available. **Please make all checks payable to Twin Cities USBC Assn.** There will be a \$35.00 fee for all returned checks.

10. MISCELLANEOUS RULES

No entry money will be returned after being received. All entries will be received in accordance with the rules of the United States Bowling Congress. **NO ENTRIES WILL BE ACCEPTED WITHOUT FULL PAYMENT!** It is the responsibility of the Team Captain to fill out and complete the entry form. Teams will roll all three games of the series on two lanes designated for that series. Doubles and Singles will bowl Doubles event first on the lanes assigned then Singles event on same pair of lanes.

No rosin or foreign substance will be allowed on lanes or approaches. Altering the surface of a bowling ball by the use of abrasives, while bowling in certified competition, is prohibited. All bowling balls so altered must be removed from competition.

11. CHECK-IN

CHECK IN IS 45 MINUTES BEFORE START TIME

Late arrivals will receive 0 pin fall for each frame missed.

Substitutes will bowl in the Lineup position of the bowler being replaced. Changes in lineup must be received Thursday before the weekend bowled.

12. OPTIONAL BRACKETS

Handicap brackets will be available for each event in the tournament depending on shift entries.
